#### Facility Priority Use Statement

"These facilities are maintained and managed under the direction of the City of Grosse Pointe for recreational opportunities for the Grosse Pointe Public School System community."

"The applicant or organization requesting the use of City/Elworthy Field facilities must be a resident of the Grosse Pointe Public School District or the organization must be located within the Grosse Pointe Public School District or be a public organization providing recreational services to residents of the Grosse Pointe Public School District. Organizations or groups requesting use of City/Elworthy Field facilities must be able to demonstrate substantial local resident participation in order to meet City rental requirements and admittance requirements."

## Platform Tennis Reservation and Court Use Procedures

### Reservation Procedures

From October 1 to April 30, the City will accept reservations for the platform tennis courts. The courts will be available Monday through Sunday, 8:00 am to 10:00 pm. Members may reserve one court per day for one-and-a-half hours at a time. Reservations may be made up to three days in advance.

To reserve a court, email or call the park office with your request no more than three days in advance. Each weekday, the reservation boards online and at Elworthy Field will be updated at 3:00 pm. The daily reservation deadline for posting will be 3:00 pm, Monday – Friday.

For evening play, reservations must be made by 3:00 pm that day. Reservations for Friday evening, Saturday, Sunday and Monday must be made by Friday at 3:00 pm. Reservations for Saturday and Sunday will not be accepted on the weekends.

Members who wish to play without court reservations can use the courts dependent upon availability. Unreserved courts are available on a first-come, first-served basis. For court availability, check the reservation board online or at Elworthy Field.

When you call to make a reservation, you must have your membership number available. Do not give your membership card or number to others to use.

When making a reservation request online, an account is required and will be set up if provided an email address. All email responses will be sent to that address on the account login.

### Schedule Changes

### Platform Tennis Court Rules and Procedures

All members will be provided with a key card with which to gain access to the courts. These cards are renewable each year, and lost cards will be assessed a \$5 replacement fee. Please do not prop the gate open.

All court lights must be turned off by 10:00 pm.

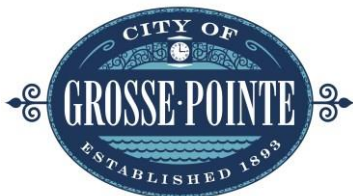
The court heaters are to dry the courts, not to be used during play to provide heat.

The equipment locker contains paddles, balls, snow shovels, lock deicer, and other equipment. Please return all equipment after use. If you notice any equipment missing or damaged, please contact the park office as soon as possible.

### Reservation Schedule

Reservation requests can be made up to three days in advance. The following chart shows the earliest day that you can send in a reservation request for a particular play time. The weekends are considered one day.

### RELEASE OF LIABILITY

To the fullest extent permitted by law, the named group or organization agrees to defend, pay in behalf of, indemnify, and hold harmless the City of Grosse Pointe, its elected and appointed officials, employees, volunteers, and others working in behalf of the City against any and all claims, demands, suits, or loss, including all costs connected therewith, and for any damages which may be asserted, claimed or recovered against or from the City of Grosse Pointe, its elected officials, employees, volunteers, and others working in behalf of the City, by reason of personal injury, including bodily injury or death and/or property damage, including loss of use thereof, which arises out of or is in anyway connected or associated with the above indicated activity & use of Elworthy Field during the indicated days, dates, and times. **I understand that I am responsible for the payment of all rental fees including field use, set-up, light usage, and any clean-up considered excessive by the City of Grosse Pointe.** I have read and understand the field use policy and rules and regulations for this request and agree that they will be honored and enforced by myself, the organization or groups I am associated with; participants, and spectators while using the permitted field. I acknowledge that failure to comply with any of the above listed guidelines will result in my field use permits being revoked and/or action by local law enforcement.

When using Elworthy Field facilities and/or participating programs at Elworthy Field, individuals, groups and organizers are asked to follow these guidelines to keep yourself and others safe. Participate, only if, you feel healthy and safe to do so. The following information must be conveyed to all affiliates within your organization, group, or team:

1. If you or a member of your immediate family is exhibiting symptoms of COVID-19 or are feeling unwell, stay home. Do not attend an activity on property owned or managed by the City of Grosse Pointe until you are symptom and fever free for 48 hours.
2. It is impossible to mitigate all risk in regard to COVID-19 or other communicable health conditions. The City of Grosse Pointe cannot guarantee a disease-free environment. In accordance to CDC guidelines of best practices for decreasing the spread of COVID-19 we encourage; use of a cloth or paper facemasks (participant/spectator discretion unless indicated otherwise upon enrollment), adherence to the suggested physical distancing parameters, providing your own hand sanitizer with at least 60% alcohol for use and applying it after contact with equipment and in-between activities or locations. Only use City facilities if you feel safe to do so.
3. A reminder that utilizing City parks, facilities, and participating in activities on City owned or managed property is of the renter and their guests' own free-will. As a park user, the renter, participants, families, and guests freely assume all risks, both known and unknown, regardless of the efforts, or lack of efforts, from the City of Grosse Pointe.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that park users, this facility renter's organization, its participants and guests may be exposed to, or infected by COVID-19; such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Elworthy Field may result from the actions, omissions, or negligence of myself and others, including, but not limited to, City of Grosse Pointe employees, volunteers, program participants and any park user. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that may be experienced as a renter or incurred in connection with my use of this facility and overall park use. On my behalf, on the behalf of my organization, participants, families, and guests., I hereby release, covenant not to sue, discharge, indemnify, and hold harmless the City of Grosse Pointe, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the City of Grosse Pointe, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any activity on property owned or managed by the City of Grosse Pointe.
